

QuickStix® Luxury Vinyl Plank & Tile Warranty

FEATURES WARRANTED

Mannington Commercial QuickStix Luxury Vinyl Plank & Tile is backed by a limited warranty for bond and manufacturing defects. The duration of the Mannington Commercial QuickStix Luxury Vinyl Plank & Tile Warranty varies per collection and matches the product warranty. Mannington Commercial QuickStix Luxury Vinyl Plank & Tile Warranty is for its original installation site(s), subject to the exclusions, conditions and limitations described below.

EXCEPTIONS AND LIMITATIONS

1. Mannington Commercial QuickStix Luxury Vinyl Plank & Tile flooring is applied as specified in Mannington Commercial's most current installation and maintenance instructions and guidelines and any other technical information available in Mannington Commercial's current technical literature and/or in manningtoncommercial.com. These instructions describe in detail the substrate condition upon which Mannington Commercial QuickStix Luxury Vinyl Plank & Tile flooring is applied. Those conditions must be appropriate at the time of installation and for the entire term of the Warranty. Reference the current ASTM F710, "Standard Practice for Preparing Concrete Floors to Receive Resilient Flooring," and ASTM F301 for additional details.
2. If the substrate fails to meet the moisture and pH requirements, at any time during the Warranty period, the Warranty shall be void.
3. If approved primer was not used before Mannington Commercial QuickStix Luxury Vinyl Plank & Tile flooring installation, the Warranty shall be void.
4. Labor for material installed with obvious defects is not covered by this Warranty.
5. Problems due to moisture, mildew, alkaline substances or hydrostatic pressure in the subfloor are not covered by this Warranty.
6. Labor costs for repair or replacement of material which was not originally professionally installed is not covered by this Warranty.
7. Customers must keep moisture testing data and substrate photos on file and provide copies to Mannington Commercial upon Mannington Commercial's request.
8. For Mannington Commercial QuickStix Luxury Vinyl Plank & Tile flooring that is applied over existing hard surface flooring, if bond failure of

the existing flooring to the substrate occurs and/or bond failure of Mannington Commercial QuickStix Luxury Vinyl Plank & Tile flooring to the surface of the existing flooring occurs, due to contamination or inadequate surface preparation, the Warranty shall be void.

REMEDIES

Mannington Commercial, at its option, may designate a representative to inspect the floor and/or have it tested by an independent testing firm. If the inspection or independent testing reveal that Mannington Commercial QuickStix Luxury Vinyl Plank & Tile flooring has not performed as stated in this Warranty, if installed by a professional flooring installer/contractor, Mannington Commercial will, at its option: (i) repair without charge the affected flooring to conform to the warranty; or (ii) replace the affected flooring without charge, with flooring of equal value and/or quality. Mannington Commercial will also pay for reasonable labor costs per the conditions stated above. Mannington Commercial will not pay for the removal or replacement of cabinets, appliances, or other fixtures. Replacement floors are warranted only for the remaining time of the original warranty and are not warranted to match samples or marketing materials (i.e. photographs, website, etc.) or match in color, dye lot, and gloss with your existing floor. All other costs, including the cost of removing equipment, furnishings, partitions, or anything else installed or placed over the carpet, are the responsibility of the end-user.

ADDITIONAL LIMITATIONS

This Warranty only covers the original end-user of the Mannington Commercial QuickStix Luxury Vinyl Plank & Tile flooring at its original installation site(s) and is not transferable.

THESE ARE YOUR EXCLUSIVE REMEDIES UNDER THE LIMITED WARRANTIES SET FORTH ABOVE. UNDER THE TERMS OF THESE LIMITED WARRANTIES, MANNINGTON COMMERCIAL WILL NOT BE LIABLE FOR INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL OR OTHER DAMAGES OF ANY KIND, NO MATTER WHAT THE CAUSE. THERE ARE NO IMPLIED WARRANTIES, INCLUDING THE IMPLIED WARRANTIES OR MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, EXTENDING BEYOND THE TERMS OF THESE LIMITED WARRANTIES. EXCEPT AS SET FORTH HEREIN, THERE ARE NO OTHER EXPRESS WARRANTIES MADE BY MANNINGTON.
