

# Revive Pressure Sensitive Tape System Warranty

---

## FEATURES WARRANTED

Mannington Commercial, a business unit of Mannington Mills, Inc. "Mannington" warrants the purchaser of its Revive Tape System subject to the exclusions, conditions and limitations described below:

Mannington warrants Revive Tape System against manufacturing defects as follows: BOND Mannington hereby warrants the bond created by Revive Tape System to be free of defect in material for the life of the floor covering.

## EXCLUSIONS

This warranty is only available if the Mannington Commercial carpet has been properly installed with Mannington Revive Tape System and subject to normal indoor use. Further, this warranty applies only to manufacturing defects, and does not cover (i) dusty or unclean substrates, (ii) deterioration of tape caused by excessive moisture or alkali, (iii) its suitability for a particular job, (iv) improper carpet cleaning methods after installation or installation of another carpet manufacturer's product, (v) improper moisture emissions testing resulting in incorrect emissions rates. **FAILURE TO ADHERE TO THE CONDITIONS SET FORTH ABOVE WILL RENDER THIS LIMITED WARRANTY NULL AND VOID.**

## CONDITIONS

The bond created by Revive Tape System is warranted to be free of defect in material and workmanship for the life of the floor covering. This warranty shall not be effective, unless the following conditions are satisfied:

1. The substrate is suitably prepared according to Mannington's Installation Guidelines.
2. Revive Tape System is properly applied according to Mannington's Installation Guidelines.
3. Calcium Chloride testing must be done according to the procedures outlined by ASTM-F-1869 for bond warranty to be valid. Acceptable results require that moisture content does not exceed 5lbs. Per 1,000 square feet per 24 hours or 80% per ASTM F 2170 RH
4. Revive Tape System should not be used on concretes slabs that do not have a vapor retardant membrane properly place above the sand layer and next to the concrete.
5. Please note that calcium chloride and in situ RH test state only the condition of the floor at the time of the test. Test results are not indicative, nor do they predict, how environmental conditions may impact moisture in the future.

## WARRANTY INFORMATION

6. All tests should be documented, and results saved.
7. Mannington's specified carpet cleaning directions are followed.

### LIMITATIONS

This Warranty covers the original purchaser of the Mannington Revive Tape System at its original installation site(s).

This warranty is not transferable. This warranty shall only be effective provided that the carpet originally was installed and subsequently has been maintained in strict compliance with the procedures recommended by Mannington Commercial. **EXCEPT AS SET FORTH HEREIN, THERE ARE NO EXPRESS WARRANTIES MADE BY MANNINGTON ON THIS TAPE. THIS WARRANTY EXCLUDES ALL IMPLIED WARRANTIES, INCLUDING IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE** (some states do not allow the exclusion or limitation of implied warranties, so this limitation or condition may not apply to you), **AND THERE ARE NO IMPLIED WARRANTIES INCLUDING IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE EXTENDING BEYOND THE DURATION OF THIS WARRANTY. EXCEPT FOR THE SPECIFIC REMEDIES SET FORTH HEREIN, MANNINGTON SHALL HAVE NO LIABILITY FOR ANY DAMAGES, WHETHER DIRECT, INCIDENTAL OR CONSEQUENTIAL (INCLUDING BUT NOT LIMITED TO, DAMAGES FOR LOSS PROFITS), RESULTING FROM THE INSTALLATION, USE, PERFORMANCE, MAINTENANCE, REPAIR OR REPLACEMENT OF THIS MANNINGTON TAPE** (some states do not allow the exclusion or limitation of implied warranties, so this limitation or condition may not apply to you).

This warranty gives you the specific legal rights, and you may also have other rights, which vary, by state. The terms of, and remedies available under, this warranty can only be modified or extended if expressly authorized, in writing, by an authorized representative of Mannington. ### MAKING CLAIMS

**REMEDIES**

Mannington, at its option, may designate a representative to inspect the seam and/or have the flooring product tested by an independent testing firm. If the inspection or independent testing reveals that the flooring products have not performed as warranted above, then Mannington will, at its option, (i) repair the affected area to conform to this Warranty, (ii) install a new flooring product of comparable quality from our current running line to replace the affected flooring product, or (iii) if replacement is not possible or commercially practicable, compensate the owner for the actual replacement cost of the yardage contained in the affected area. "Replacement cost" means the cost of (i) replacement Mannington flooring product of comparable quality in a yardage sufficient to cover the affected area, (ii) freight to the installation site, (iii) materials necessary for installation, and (iv) installation of the replacement flooring product. All other costs, including the cost of removing equipment, furnishings, partitions or anything else installed or placed over the flooring, are the responsibility of the owner. These are the exclusive remedies under the limited lifetime warranty set forth above.
